7 RESOLUTION NO. of 2020

RE-ADOPTION OF THE VILLAGE OF UNION SPRINGS LOCAL WATERFRONT REVITALIZATION PROGRAM

WHEREAS, the Village of Union Springs ("the Village") initiated preparation of a Local Waterfront Revitalization Program ("LWRP") including certain proposed local laws to support said program in cooperation with the New York State Department of State in accordance with the provisions of Executive Law, Article 42; and

WHEREAS, on March 17, 2020 the Village Board of Trustees held public hearings on, and subsequently adopted, by separate resolutions, each of the following local laws which support the implementation of the LWRP:

- Local Law #1 of 2020: Village of Union Springs Waterfront Consistency Review Law
- Local Law #2 of 2020: Amendments to the Zoning Law to include historic preservation considerations during site plan review
- Local Law #3 of 2020: Village of Union Springs Dock and Mooring Law
- Local Law #4 of 2020: Village of Union Springs Stormwater Management, Erosion, and Sediment

WHEREAS, in accordance with Article 8 of the New York State Environmental Conservation Law, known as the State Environmental Quality Review Act, and regulations of 6 NYCRR Part 617 adopted thereunder (collectively, "SEQRA") on March 17, 2020 the Village Board of Trustees, as lead agency, passed a resolution determining that adoption of the LWRP and each of the associated local laws, including the Stormwater Management, Erosion, and Sediment Control Law, will result in no significant adverse impact on the environment, and accordingly issued a negative declaration; and

WHEREAS, on March 17, 2020 the Village Board of Trustees held a public hearing on the draft LWRP and subsequently adopted said LWRP on said date; and

WHEREAS, The New York State Department of State has requested amendments to the text of the formerly adopted LWRP which do not change the intent nor scope of the document therefore a reevaluation of the SEQRA process is not necessary however, said amendments require the Village Board of Trustees to re-adopt the LWRP; and

WHEREAS, on September 16, 2020 the Village Board of Trustees held a public hearing on the revised LWRP at the request of the New York State Department of State; and

WHEREAS, the Village Board of Trustees and Planning Board are committed to implementing the LWRP and continuing to make improvements to the community that foster economic development, better public access to the waterfront, resiliency of infrastructure, and protection of sensitive natural resources in accordance with the policies and projects provided in the LWRP; NOW, THEREFORE, BE IT

RESOLVED, that the Local Waterfront Revitalization Program for the Village of Union Springs is hereby adopted by the Village of Union Springs Board of Trustees; and be it further

RESOLVED, that the Mayor is hereby authorized to submit a signed copy of this resolution, a copy of the adopted LWRP, and any other information or documentation necessary to the NYS Department of State for final review and approval by the Secretary of State; and be it further

RESOLVED, that this resolution shall take effect immediately.

LWRP VISION STATEMENT & GOALS

The Waterfront Revitalization Area of Union Springs will become recognized as one of the most attractive and desirable areas in the Finger Lakes. The preservation of community character and natural resources will be balanced with economic and cultural development. A Historic Business District complementing the activities and natural areas all along the waterfront will be a bustling center of commerce that serves both the residents of the community and tourists year round.

This vision will become a reality through the implementation of the Village of Union Springs Local Waterfront Revitalization Program which is a locally designed, comprehensive land and water use plan which seeks to coordinate environmental, recreational, and economic prospects and concerns into a cohesive framework that respects local interests while complying with local and state policies for a sustainable revitalization endeavor. The program is founded upon three major themes:

- Rejuvenate: The ultimate goal for rejuvenation of the Waterfront Revitalization Area (WRA) is responsible
 economic growth and an enhanced quality of life for residents and visitors. This rejuvenation will be
 realized by creating a revitalized Historic Business District through building facade and streetscape
 improvements; and by providing improved services, programs, events, facilities, and environmental
 stewardship throughout the entire WRA.
- Capitalize: In order to take advantage of the social, political, and financial resources at our disposal, the
 community will not just engage in fostering existing talents, but also actively seek to increase them by
 encouraging and supporting entrepreneurship to expand the community's offerings. This capitalization
 will be achieved through volunteerism, grants, sponsorships, fundraising events, and projects.
- Distinguish: The community will distinguish itself from other lakefront communities in the Finger Lakes
 Region by recognizing and highlighting the economic, environmental, historical, cultural, and humanitarian
 assets and contributions that the Village of Union Springs area is home to. This will be accomplished
 by celebrating these resources and collaborative initiatives via events, marketing strategies, and or
 capitalization programs that directly or indirectly highlight the excellence of the community.

GOALS

- 1. Encourage younger families to move into the area to support the school system and local businesses.
- 2. Expand local tourism by building on the current successes that exist in the community. Support the development of new and enhanced tourism opportunities that will help extend the tourism season past the summer months.
- 3. Revitalize downtown and public areas to make the community more inviting and walkable for residents and tourists.
